

CRM Long/Short Opportunities (Fund) is a long/short equity fund that seeks to provide attractive absolute returns with below market volatility and lower correlation, while allowing stock selection to drive alpha¹ on both sides of the portfolio. The fund seeks to invest in companies, across all market capitalizations and sectors, which are being impacted by change or undertaking transformation. The objective of the fund is to seek long-term capital appreciation. The strategy adheres to the same repeatable, research-driven investment philosophy and process, which has been the hallmark of the Firm's 50 year history. 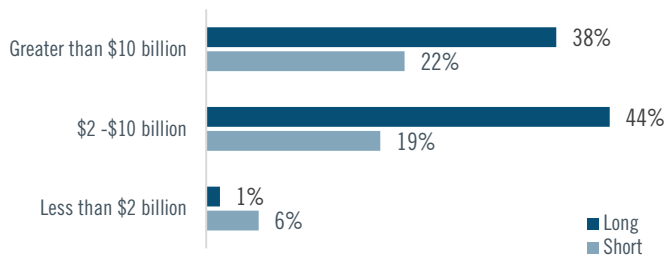

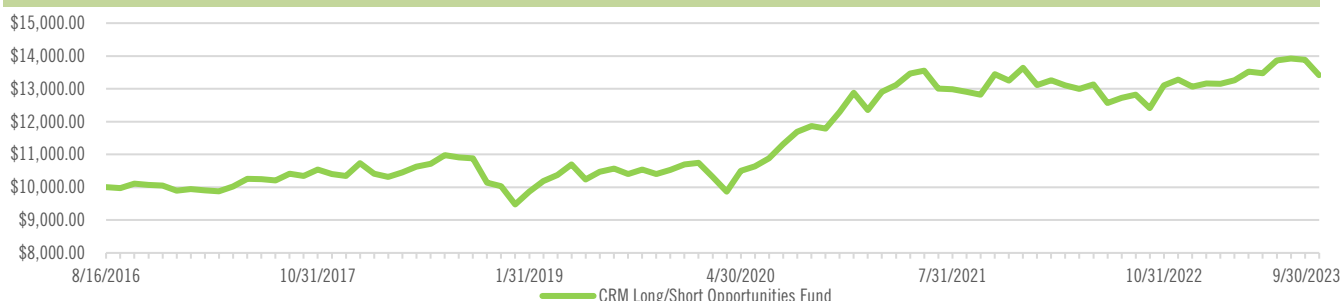

Maximum drawdown is an indicator of downside risk over a specified time period. **Beta:** is a measure of the volatility—or systematic risk—of a security or portfolio compared to the market as a whole. **Correlation:** is a statistic that measures the degree to which two variables move in relation to each other.

The Fund makes money on a short position if the market price of the stock goes down after the short sale. Conversely, if the price of the stock goes up after the short sale, the Fund will lose money because it will have to pay more to replace the borrowed stock than it received when it sold the stock short.
