The fund seeks to invest in companies, across all market capitalizations and sectors, which are being impacted by change or undertaking transformation. The objective of the fund is to seek long-term capital appreciation. The strategy adheres to the same repeatable, research-driven investment philosophy and process, which has been the hallmark of the Firm's 50-year history.
